 - 1. Welcoming Ordinance/Resolution/Policy
 - City Attorney Roger Knutson explained that ordinances are to regulate people and properties within city limits. Ordinances would regulate how employees should respond to situations.
 - Ordinance would apply to a resident of Falcon Heights not city employees and policies apply to city employees. For contracted services, the specific language should be written in the contract.
 - It was determined by the Council that the best approach would be for staff to draft a policy that would be included in the Administrative Manual.
 - Staff will draft policy with this intent and language. Policy will be in administrative manual.
 - Comments from resident Javi Monardez In favor of this ordinance as an international student.
 - 2. Guidelines to Request Agenda Items
 - Director from League of Minnesota Cities Dave Unmacht will discuss this topic. Council should think about formalization and ways to address each Council Member.
 - It was recommended that each Council Member review the email that was sent and research what other communities are doing.
 - Operating guidelines will be created and other community examples will be looked at during this process.
 - 3. 2021 Proposed Budget
 - a. Special Revenue Funds

- The Government Accounting Standards Board (GASB) issued Statement No. 54 in 2011, to clarify the definition of special revenue funds, as there was some ambiguity before. From the Statement: "Special revenue funds are used to account for and report the proceeds of specific revenue sources that are restricted or committed to expenditure for specified purposes other than debt service or capital projects."
- Park Program \$26,000 transferred from General to Special Revenue fund
- Pull tabs is not an huge revenue source
- Conduit Bond Revenue can be used for anything, there are no restrictions.
- Street lighting project will need to be completed.
- Council has wanted to maintain \$30,000 funding in the inclusion fund.
- b. Enterprise Funds
- The Government Accounting Standards Board (GASB) describes enterprise
 funds in its Codification of Governmental Accounting and Financial
 Reporting Standards. It states that enterprise funds may be used to report
 and activity for which a fee is charged to external users for goods or
 services.

- Funds are used to account for and report financial resources that are restricted, committed, or assigned to expenditure for principal and interest.

 - Parks and Recreation Commission to get information in the welcome packet about the Community Garden.

1. CARES Act - Coronavirus Relief Funds

City Administrator Thongvanh

The CARES Act established the \$150 billion Coronavirus Relief Fund. The CARES Act requires that the payments from the Coronavirus Relief Fund only be used to cover expenses that qualify.

The City of Falcon Heights has been allocated \$412,789. The City will need to submit a certification form for fund distribution from the State by September 15. If the funds have not been requested by September 15, unused/unclaimed funds will be available for the State to use.

Council Member Wehyee

Council Member Wehyee thinks its great our community can benefit from these funds.

Council Member Leehy

In regards to the HVAC, is it being looked into having different zones?

City Administrator Thongvanh

We are looking to retrofit devices into the system using ultraviolet light.

Council Member Miazga

Are the expenses for the law enforcement contract expected to have a significant variance?

City Administrator Thongvanh

We are trying to figure out if the funds can be used for the existing contract. When an officer goes to a call they are preparing for COVID. Waiting to have this defined.

Council Member Andrews

Can we use the funds for businesses?

City Administrator Thongvanh

That is one recommendation. Research is being conducted from other cities to see what type of grant could be created to assist businesses and what the qualifications would look like.

| | The purpose of this regional project is to better manage stormwater runoff from the City of Falcon Heights, City of Lauderdale, Ramsey County, and the University of Minnesota, and to reduce a historic flooding issue at an apartment complex located at 1568 Eustis Street in the City of Lauderdale. The stormwater runoff from the 148-acre drainage area currently overwhelms the existing storm sewer system and can cause impacts to the apartment complexes parking lot in a 10-year storm, and has the potential to impact the apartment building in the 100-year storm. |
| | CRWD has been the lead agency, and they hired Barr Engineering to model the drainage area to determine peak flows and potential impacts. As part of the project, Barr looked at potential solutions to minimize the flooding issue, and also improve water quality. The most cost-effective solution to minimize impacts and to improve water quality was to retrofit Seminary Pond with additional storage capacity and to install an iron-enhanced sand bench. The pond will help alleviate peak flows, and the iron-enhanced sand bench will provide water quality treatment by helping removing phosphorus from the stormwater. |

Falcon Heights will also get stormwater volume banking credits which the City can use in the future to offset permit requirements. During the development of this project it became apparent that an agreement be established for drainage projects between the City and the University of Minnesota. Both parties drain onto the other party's jurisdiction and pipe network creating a need to have an agreement in place to document who pays for maintenance and improvements. A 1982 agreement and easement between the UofM and the City was found during the project development. It has not been followed for years and is need of updating to better align with new drainage rules and desires for both parties. A memorandum of agreement is attached which lays the groundwork for updating drainage agreements for the City and Falcon Heights. 6.2. The Partners will issue all necessary permits and provide all necessary approvals to construct the Project at no cost to CRWD.

- 7. Maintenance Responsibility for Project Elements
 - 7.1. An operation and maintenance plan will be developed by CRWD during construction of the project. Lauderdale, Falcon Heights, and Ramsey County will review and concur with the O&M plan prior to finalizing.



AGREEMENT

THIS AGREEMENT, made and signed this HM day of Avgust, 1982, by and between the City of Falcon Heights, hereinafter called the "City" and the Regents of the University of Minnesota, hereinafter called "University".

In consideration of the terms and conditions hereafter set forth, the City and University agree as follows:

- 1. Subject to the following provisions, the University grants to the City permission to connect a 21 inch diameter reinforced concrete storm sewer pipe from the Fairview-Larpenteur area of the City into the University's relief storm sewer system at the point identified as MH-11, on the University's plans drawing number 11145, dated 5-8-63.
- 2. The City may discharge storm water into the University system in an amount not to exceed 16 cubic feet per second. The area to be drained is shown on the storm sewer district map attached hereto as Exhibit A and by reference made a part hereof.
- The City shall pay all costs of installation and connection to the University system and all the costs of restoration.
- 4. The City shall locate the storm sewer on Gortner Avenue between Larpenteur Avenue and point MH-11. The sewer trench will be backfilled at the end of each day of construction. The area disturbed will not exceed 36 feet in width located from a line 1 foot west of the existing west edge of bituminous pavement to a line 36 feet east of said line within the field plot area of the road.

The City shall place temporary fences on both sides of the construction area to prevent disruption beyond the 36 foot wide restriction in the field plot area. The University reserves the right to inspect the construction site and reserves the right to shutdown the project if construction is not proceeding as agreed. The City shall provide access to all University buildings at all times during construction.

- 5. Upon completion of the storm sewer or in the event the project is shutdown by the University as herein provided, the City shall restore Gortner Avenue with a 34 foot wide 9 ton design roadway consisting of 8 inches of Class 5 aggregate, 2-1/2 inches of bituminous base course, and 1-1/2 inches of bituminous wear course. Concrete curb and gutter, where removed, will be replaced. Sod will be installed and growth restored in all disturbed turf areas. Gortner Avenue will be striped to meet University requirements.
- 6. The City agrees that the construction, including restoration, will be started an completed within the period between August 16, 1982 and September 24, 1982, time being the essence of this Agreement.
- The City shall provide full time qualified inspection during construction.
- 8. The City shall allow the University to review all plans and specifications prior to bids and allow changes in accordance with conditions of this agreement.
- 9. The City shall obtain approval from the City of St. Paul or any other required governmental approvals for the proposed storm sewer connection to the University system and shall promptly pay all connection and other charges associated with the connection to and use by the City of storm sewer system.

- 10. For the connection to and use of the University storm sewer system, the City shall pay a one time connection charge to the University of \$33,230.00 (\$31,650.00 plus a 5% charge for administrative cost). In addition, the City shall participate in repair and maintenance costs of the University relief storm system, and the cost of replacement of the University relief storm system in proportion to the City's contributing flow of 16 cubic feet per second compared to the capacity of the University relief storm system as identified in Exhibit B attached hereto and by reference made a part hereto. (Estimated end of life is year 2043 for the University system using an 80 year life).
- 11. The City and University mutually agree to inspect the condition of the existing storm sewer prior to City's construction of the storm sewer. Discovery of major defects will allow the City to void this agreement, if desired. Cost sharing of any repairs necessary will be negotiated between parties.
- 12. The City shall not permit or allow any debris or other substances to be discharged into the storm sewer system in violation of applicable law or regulations.
- 13. The City shall hold the University harmless from and against any and all liability, demands, causes, actions or claims, whether well-founded or otherwise, including the cost of defending the same, which in any way may arise out of or in connection with the granting of this permission, or the construction, installation, connection or surface restoration or use by the City of the University system. Further, the University shall not be responsible to the City or any other party served by the City, for any damages, con-


sequential or otherwise, for the use or disruption of service by the City's connection or use of the system. All contractors engaged by the City shall give suitable and adequate bonds to the City to insure timely and satisfactory performances of the contracts, and to require adequate liability insurance to indemnify the City and its responsibilities to the University pursuant to this agreement.

- 14. The University shall, on or before had the give to the City a temporary construction easement and a permanent easement for construction and future maintenance of the proposed storm sewer. The City shall survey the easement location and prepare the easement documents incorporating the pertinent provisions of this agreement and in form satisfactory to the University. The City shall coordinate with the University any future mainentance activity that would involve disruption of traffic.
- 15. The University agrees to allow rubber tire type construction equipment to use Folwell Avenue for access only during construction, but such use shall not be in a manner to cause damage.

MEMORANDUM OF AGREEMENT

This Memorandum of Agreement ("Agreement") is entered into on the date of last signature below (the "Effective Date") by and among Regents of the University of Minnesota, a Minnesota constitutional corporation ("University"), Capitol Region Watershed District, a watershed district created pursuant to Minnesota Statutes chapter 103D ("CRWD"), and the City of Falcon Heights, a municipal corporation ("Falcon Heights").

RECITALS

WHEREAS, CRWD proposes to make certain improvements to Seminary Pond in Lauderdale, Minnesota, to improve flood protection, water quality, and natural areas to the benefit of surrounding communities like Falcon Heights, the City of Lauderdale, Ramsey County, and the University;

WHEREAS, the CRWD-led Seminary Pond project includes pond excavation, installation of iron-enhanced sand filters, replacement and repair of storm sewer infrastructure, grading, raising the pond berm, installation of rock and other erosion control measures, establishment of long-term maintenance access, and site restoration with native vegetation (the "Project");

WHEREAS, CRWD is seeking contributions from the surrounding communities to fund the Project; and

WHEREAS, the University is willing to contribute toward the cost of the Project, but seeks a broader agreement related to stormwater management in the CRWD and Falcon Heights.

NOW THEREFORE, in consideration of the shared benefits offered by the Project and the mutual promises contained within this Agreement, the University, the CRWD and Falcon Heights agree as follows:

- 1. Contribution. The University shall make a one-time contribution equal to \$58,715 to CRWD. University will execute a cooperative funding agreement to this effect.
- 2. Stormwater Management. Within five (5) years after the Effective Date, the University, CRWD and Falcon Heights commit to negotiating an agreement related to stormwater management issues in the CRWD and Falcon Heights. The agreement will address issues including (but not necessarily limited to) future drainage from University property to Seminary Pond, drainage from properties under Falcon Heights's jurisdiction to University stormwater conveyance systems, and related operation and maintenance issues. The parties acknowledge that some of the issues are addressed in that certain Permanent Storm Easement dated September 3, 1982 and the August 4, 1982 Agreement (the "1982 Agreement") referenced therein and agree that the 1982 Agreement may be amended, terminated, reinforced, or left alone as a part of the parties' negotiations related to stormwater management issues.

- 3. Indemnity. Each party shall be responsible for its own acts and the acts of their employees, volunteers, and agents and the results thereof to the extent authorized by law and shall not be responsible for the acts of another party or the results thereof. The University's liability is subject to the limits provided for in the Minnesota Tort Claims Act, Minn. Stat. § 3.736. CRWD and Falcon Heights's liability are both subject to the limits provided for by Minnesota law, specifically including those in Minnesota Statutes, Chapter 466.
- 4. Force Majeure. The obligations of the parties hereto are subject to force majeure and no party shall be in default under this Agreement if any failure or delay in performance is caused by a labor dispute; accidents; acts of God; fire; flood; earthquake; unusually severe weather; material or facility shortages or unavailability not resulting from such party's failure to timely place orders; lack of transportation; acts of any governmental authority; condemnation or the exercise of rights of eminent domain; acts of terrorism or war or civil disorder; pandemic; or any other cause beyond the reasonable control of the parties hereto. The excused party shall use reasonable efforts under the circumstances to avoid or remove such causes of non-performance and shall proceed to perform with reasonable dispatch whenever such causes are removed or ceased.
- **5. Notices.** Unless otherwise provided herein, all notices and communications concerning this Agreement shall be in writing and addressed as follows:

Unless otherwise provided herein, notices shall be sent by certified U.S. Mail, return receipt requested, or by commercial overnight delivery service which provides acknowledgment of delivery, or by facsimile, and shall be deemed delivered: if sent by U.S. Mail, five (5) days after deposit; if sent by email, or commercial overnight delivery service, upon verification of receipt.

- **6. Assignment.** No party shall assign this Agreement or the rights hereunder to any other party without the prior written consent of the other parties. Each of the parties' respective rights and obligations hereunder shall be binding upon and shall inure to the benefit of the parties hereto and each of their respective permitted successors and assigns.
- **7. Amendment.** This Agreement shall be amended only in a writing mutually agreed upon and duly executed by the parties.
- **8. No Real Property Interest Granted.** No party shall obtain a property interest or estate in or lien upon another's property or facilities. All liens, claims and charges of each party shall not attach to any real property interest of the other parties' property.
- 9. Governing Law & Venue. This Agreement shall be interpreted and construed in accordance with the internal laws of the state of Minnesota.
- 10. Independent Contractor. The performance by the parties of all duties and obligations under this Agreement shall be as independent contractors and not as agents of the other parties, and no persons employed or utilized by a performing party shall be considered the employees or agents of another party. No party shall have the authority to enter into any agreement purporting to bind another party without specific written authorization. The parties agree that this Agreement does not create a partnership between, or a joint venture.
- 11. Non-Waiver. No failure to exercise and no delay in exercising, on the part of any party hereto, any right, power or privilege hereunder shall operate as a waiver hereof, except as expressly provided herein. Any waiver by a party of a breach of any provision of this Agreement shall not be deemed to be a waiver of any other or subsequent breach and shall not be construed to be a modification of the terms of this Agreement unless and until agreed to in writing by all parties.
- 12. No-Third Party Beneficiaries. This Agreement is solely for the benefit of the parties hereto and their permitted successors and assigns.
- 13. Entire Agreement. This Agreement, any Exhibits and Attachments referenced and attached hereto or to be attached hereto, constitute the entire agreement between the parties hereto with respect to the subject matter hereof and supersede any and all prior negotiations, understandings and agreements with respect hereto, whether oral or written.
- 14. Counterparts; Electronic Exchange. This Agreement and any amendments to it may be executed in duplicate copies on behalf of the parties by their authorized representatives. Each duplicate copy shall be deemed an original, but all duplicate originals together shall constitute

one and the same instrument. The executed counterparts of this Agreement may be delivered by electronic means, such as email, and the receiving party may rely on the receipt of such executed counterpart as if the original had been received.

| Description | In cooperation with Capital Region Watershed (CRWD), the City of Lauderdale, Ramsey County and the University of Minnesota, city staff has been working with the agencies to develop a cooperative agreement for a regional drainage project, Seminary Pond, in Lauderdale that drain the western side of Falcon Heights. As a secondary project to the Seminary Pond project is the restoration of the storm sewer outfall that serves the storm water drainage from the Grove neighborhood. Staff has worked with CRWD to create a cooperative agreement. The outfall project involves restoring the ditch downstream of the outfall which has been severely eroded overtime. Work involves tree removal, grading, installation of additional storm sewer, turf stabilization and tree restoration. The new design should eliminate the erosion concern and make maintenance easier. The agreement defines the roles and responsibilities for each party. All engineering costs would be paid by CRWD. The estimated costs the Falcon Heights share of the construction costs are 100% of the construction costs estimated to be \$100,000. |
| | The project is schedule for bid in early September with construction later this fall. This portion of the project is being bid as an alternate so it could be removed from the project if the costs are too high. |

This Agreement is between the Capitol Region Watershed District, a watershed district created pursuant to Minnesota Statutes chapter 103D ("CRWD"), City of Falcon Heights, a municipal corporation ("Falcon Heights"), and City of Lauderdale, a municipal corporation ("Lauderdale"), to apportion rights and responsibilities related to the construction and maintenance of the Folwell Avenue and Fulham Street outfall improvements in Falcon Heights and Lauderdale, Minnesota ("Project").

- 3. The Project area is partially located in Falcon Heights and Lauderdale. Falcon Heights will secure any additional easements and access permissions from property owner(s) necessary for the construction and long-term maintenance of the Project.
- 4. Falcon Heights will provide long-term maintenance of Project.
- 5. The Project includes extension of storm sewer pipe, installation of other storm sewer infrastructure, grading, and site restoration with native vegetation.
- 6. CRWD will manage the design and construction of the Project on behalf of Falcon Heights.

AGREEMENTS

- 1. Responsibility for Design Engineering
 - 1.1. CRWD is responsible for the preparation of all plans, specifications, proposals, and estimates for the Project.
 - 1.2. CRWD shall be responsible for 100% for all costs related to design engineering of the Project.
 - 1.3. Any changes requested after final design shall be the fiscal responsibility of the party requesting the change.
- 2. Procurement and Award of Contract
 - 2.1. CRWD will take bids in accordance with state law, watershed district statute and City rules.
 - 2.2. CRWD will award a contract and pay the contractor for all costs related to the Project.
- 3. Responsibility for Construction Engineering
 - 3.1. CRWD shall perform or contract the performance of the construction engineering for all elements of the Project.
 - 3.2. CRWD shall be responsible for 100% for all costs related to construction engineering.
- 4. Responsibility for Construction
 - 4.1. CRWD shall perform or contract the performance of the construction of the Project.
 - 4.2. Falcon Heights will be responsible for 100% of construction costs.

5. Payment Schedule

- 5.1. CRWD will invoice Falcon Heights for construction costs after final completion of the Project.
- 5.2. Falcon Heights will pay one-third of total actual construction costs by December 1st for three years starting in 2021 and ending in 2023.

6. Easement and Access Rights

- 6.1. Falcon Heights will be responsible for securing all easement and access rights to construct, inspect, monitor, maintain, and repair the Project.
 - 6.1.1. Falcon Heights will acquire necessary easements and permissions on behalf of CRWD to perform the Project.
 - 6.1.2. Falcon Heights will secure necessary rights to allow CRWD to access the project site to provide tours of the Project.
 - 6.1.3 Lauderdale will grant permission to CRWD and Falcon Heights for the construction of the Project within its jurisdiction.
 - 6.1.4 Falcon Heights will obtain an easement from Lauderdale upon final completion of the Project.
- 6.2. Falcon Heights will issue and obtain all necessary permits and provide all necessary approvals to construct the Project at no cost to CRWD.

7. Maintenance Responsibility for Project

7.1. Falcon Heights will be responsible for operation and maintenance of the Project and 100% of the O&M costs.

8. Ownership

8.1. Falcon Heights shall retain ownership and responsibility of the entire Project. CRWD and Lauderdale do not assume any responsibility of the Project except as specifically identified herein.

9. CRWD, Falcon Heights and Lauderdale shall indemnify, defend, and hold each other harmless against any and all liability, losses, costs, damages, expenses, claims, or actions, including attorney's fees, which the indemnified party, its officials, agents, or employees may hereafter sustain, incur, or be required to pay, arising out of or by reason of any act or omission of the indemnifying party, its officials, agents, or employees, in the execution, performance, or failure to adequately perform the indemnifying party's obligation pursuant to this Agreement. Nothing in this Agreement shall constitute a waiver by CRWD, Falcon Heights, or Lauderdale of any statutory or common law immunities, limits, or exceptions on liability.

10. Other provisions

- 10.1. This Agreement shall remain in full force and effect until terminated by mutual agreement of the parties.
- 10.2. Cooperation and Compliance with Minnesota and Federal Law. Parties agree to cooperate in any manner necessary to effectuate this agreement or complete the Project. Parties understand that funding for the Project includes funds from CRWD and Falcon Heights and that each of these sources might have requirements for funding, contracting, procurement, data practices, prevailing wage, or record-keeping that is in addition to those included herein. Parties agree to cooperate in meeting any of these additional obligations.
- 10.3. Records. All parties agree to maintain records of costs pertaining to the Project in accordance with Minnesota Statutes and relevant internal record keeping and accounting procedures.
- 10.4. Modification. It is understood and agreed by the parties hereto that this agreement shall not be modified or amended except in writing duly signed by each of the parties.
- 10.5. This agreement may be executed individually in counterparts, with each part an original, and together all parts form a single document.



D. <u>STANDARDS CONCERNING COMMUNICATION AND ENFORCEMENT OF</u> IMMIGRATION LAWS

I. Purpose

Although the City works cooperatively with the Department of Homeland Security, as it does with all state and federal agencies under relevant state and federal laws, the City does not operate its programs for the purpose of enforcing federal immigration laws.

II. In General

In conformity with state and federal law, when determining eligibility for, and providing general city services, city employees and officials shall:

- (1) Complete I-9 forms, question a person regarding the I-9 form and documents supporting the I-9 form, and may allow Homeland Security to audit the I-9 forms as required by law.
- (2) City employees shall request and inquire about immigration status only when specifically mandated to do so by law. As a corollary, City employees shall solicit evidence of a person's identity only when necessitated by the employee's work duties. City employees shall not discriminate against any current or potential service users based on race, sexuality, creed, religion, disabilities, immigration status, or any other identity factor.
- (3) Other than complying with lawful subpoenas, city employees and representatives shall not use city resources to detect or apprehend persons whose only violation of law is or may be being undocumented, being out of status, or illegally residing in the United States (collectively) undocumented.
- (4) A Minnesota issued driver's license and or a photo identity document issued by the person's nation of origin such as a driver's license, passport, or matricula consular are each adequate evidence of identity and the possession of either shall not subject the person to higher levels of scrutiny or different treatment. This paragraph does not apply to I-9 forms.

General city services means all city services except services specifically listed as public safety services in Section III.

III. Public Safety

In conformity with state and federal law, when performing public safety duties, city employees, shall:

(1) Not perform any public safety action for the purpose of detecting the presence of undocumented persons, or to verify immigration status, including but not limited to questioning any person or persons about their immigration status.

(2) Shall not question, apprehend or detain any person for violations of federal civil immigration laws except when immigration status is an element of the crime or when enforcing 8 U.S.C. 1324(c).

All public safety conduct related to the communication and enforcement of civil immigration law shall be documented and made available to (a) the City Attorney, (b) City Council, and (c) the City Administrator. The report shall include any applicable Department of Homeland Security mission statement and operational guidelines, the reason for the dispatch of personnel, the name of the homeland security agent in charge, and the name of the officer authorizing the use of city personnel.

The City shall make all efforts to contract with public safety agencies, including the police that abide by the standards and practices of Public Safety Officers in this Section.

IV. Complaints and Discipline

Violation of this Policy shall be subject to disciplinary action under the appropriate union contract, civil service commission rules, or Falcon Heights Personnel Policy. It shall not be a violation of this chapter to require the completion of I-9 forms or to inquire into or disclose the immigration status of the complainant or witnesses if necessary as part of the investigation of a complaint of a violation of this chapter, or if deemed necessary by the appointing authority to administer discipline for such violations.

V. Subpoena

This policy does not prohibit city employees from responding to a properly issued subpoena.
