1. State Fair Recap

- i. Police Calls/Ticketing

1. The task force discussed the number of tickets issued, and the fact that numbers were trending down.
 2. Typical Call numbers: 5 per day normally. 50 per day during the State Fair

- ii. What went well?

1. Sign Distribution for "Please Be Good to Our Neighborhood" Signs and post event retrieval went well

- i. Several Task Force members have aided in delivery of signage
 - 2. Pedicabs seemed to follow updated registration policy
 - 3. Lighting at Curtiss Field
 - 4. Permits seemed to be easier for police to monitor
 - 1. 600 printed
 - iii. What Could be better?
 - 1. First 2 days of the Fair are the worst for Falcon Heights City Hall
 - 1. Concern raised that city staff's summer hours meant they were closed at noon on Friday.
 - 2. Option to provide Staff Overtime or allow time off after the Fair instead
 - 3. Linehan continued answering calls, but this was not common knowledge
 - i. Get volunteers to man the phones (Monday before the fair, through the Tuesday after the Fair). They could divert calls using a flow chart and reduce stress on City employees.
 - 2. Crossing assistance for walkers and motorists by the Larpenteur/Fry intersection
 - 1. Matter of time before there is a fatality
 - 2. Accidents are increased in this area during the State Fair.
 - 3. Elevate Police presence
 - 1. National Guard, Police Corp, Volunteers, Community Ambassadors, State Patrol
 - 4. Escalate to a STATE level responsibility
 - 1. Several legislators are interested in crowd management during the State Fair (Senator Clare Verbeten lives close to the Fairgrounds)
- 2. Post – State Fair Survey/ Feed Back
 - i. 2024: 104 responses so far
 - 1. Mostly from NE Quadrant and Northome
 - 2. Safety and Policing
 - 1. Visibility- 65% saw regular patrols
 - 2. Adequacy-33% felt police presence was adequate
 - 3. Safety at home-75% felt safe during the Fair
 - 3. Parking
 - 1. Enforcement- 28% felt it was adequate
 - 2. Permit Only areas- 33% wish to increase number of areas
 - 4. Traffic/Noise
 - 1. Congestion: 50+% said it was worse
 - 2. Most residents felt noise was the same
 - 5. Litter/Property respect
 - 1. Half feel litter was improved

2. 67% agree fairgoers had respect for property
6. New Policies
 1. 78% didn't notice changes to pedicabs
 2. 66% liked the signage and curb marking
7. Future Improvements
 1. Commercial Parking: Half agreed that regulation would help
 2. Resident compensation: Most would like free, reduced cost or season pass option for those within a geographic distance to the Fair
 3. Policing
 - i. Enforcement and presence top the list of suggestions.
3. Next Steps
 - i. Talk to Senator Verbeten and other Representatives about getting State level aid
 - ii. Codify Commercial Parking Licensure

Item	Preliminary Survey Data
Description	<p>Overview: The 2024 State Fair survey, launched on Monday, September 9th, has now gathered 145 responses as of October 11, 2024. The survey aimed to assess the impact on neighborhoods, focusing on safety, parking, traffic, policing, and general quality of life.</p> <p>Key Findings:</p> <ol style="list-style-type: none"> 1. Neighborhood Representation: <ul style="list-style-type: none"> ○ 145 residents responded to the survey. The majority reside in the Northeast Quadrant (38%) and Northome (34%), consistent with previous reporting from high-impact areas near the fairgrounds. 2. Safety & Policing: <ul style="list-style-type: none"> ○ Policing Visibility: 60% of respondents reported not seeing police patrols during the fair, a slight decline from previous reports. The frequency of patrols remains inconsistent, with some residents noting seeing police only once or twice during the entire fair period. ○ Adequacy of Policing: 34% of residents felt policing was adequate outside the fairgrounds, while 22% disagreed, citing slow response times to traffic control and parking violations. ○ Neighborhood Safety: 78% of respondents agreed they felt safe in their neighborhoods during the fair, with only one respondent strongly disagreeing that they felt safe in their neighborhood. 3. Parking Challenges: <ul style="list-style-type: none"> ○ Parking Enforcement: 42% of respondents agreed parking enforcement was adequate, with 17% expressing dissatisfaction. Numerous complaints arose around illegal parking, delayed responses, and unauthorized vehicles parked in permit-only zones. ○ Permit Parking: Support for expanding permit-only parking has increased to 35%, with some respondents pushing for broader implementation to prevent illegal parking by fairgoers. The majority of respondents (65%) oppose citywide State Fair parking permits.

4. Traffic & Noise:

- **Traffic Congestion: 55% of respondents** reported traffic being worse than in previous years. Increased pedestrian and vehicle traffic, particularly in high-demand areas, has resulted in safety concerns and delays for residents.
- **Noise:** Noise complaints decreased, with 17% of residents reporting that noise levels were worse than in 2023, especially from late-night traffic and fair-related events.

5. Litter & Property Respect:

- **Litter: 46%** of respondents agreed litter was less of an issue compared to previous years, likely due to the improved placement of trash receptacles and curb markings. However, isolated incidents of littering were still reported.
- **Respect for Property: 69%** of residents agreed fairgoers generally respected personal property, though some noted trespassing and occasional vandalism.

6. Impact of New Policies:

- **Pedicab Regulation: 79%** of respondents did not notice significant changes in pedicab behavior following new regulations. Some residents, however, cited concerns about loud music and reckless driving by pedicab operators.
- **Signage & Curb Markings: 67%** of residents felt that no-parking signage and curb markings helped reduce parking issues. However, several respondents reported fairgoers moving or ignoring the signs, which contributed to ongoing parking violations.

7. Feedback on Future Improvements:

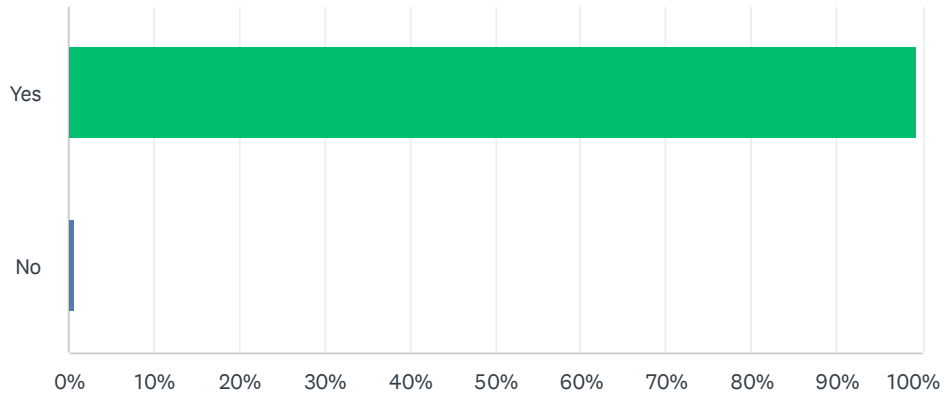
- **Commercial Parking Regulation: 50%** of residents supported the idea of regulating businesses that sell parking during the fair to address safety concerns and reduce traffic.
- **Resident Compensation:** Many residents advocated for compensation, such as free or discounted fair tickets, in recognition of the inconveniences caused by the fair.
- **Enforcement & Policing:** Respondents suggested increasing the number and visibility of police patrols, especially during peak traffic hours, and more aggressive enforcement of parking restrictions. There were also calls for pedestrian safety measures at busy intersections.

Conclusion: The updated survey data continues to highlight concerns among Falcon Heights residents, particularly around parking enforcement, traffic congestion, and noise during the State Fair. While some improvements have been noted, such as better litter management and increased awareness of signage, residents are calling for stronger traffic and parking regulations, better enforcement, and potential compensation for the event's disruptions.

Q2 Are you a Falcon Heights resident?

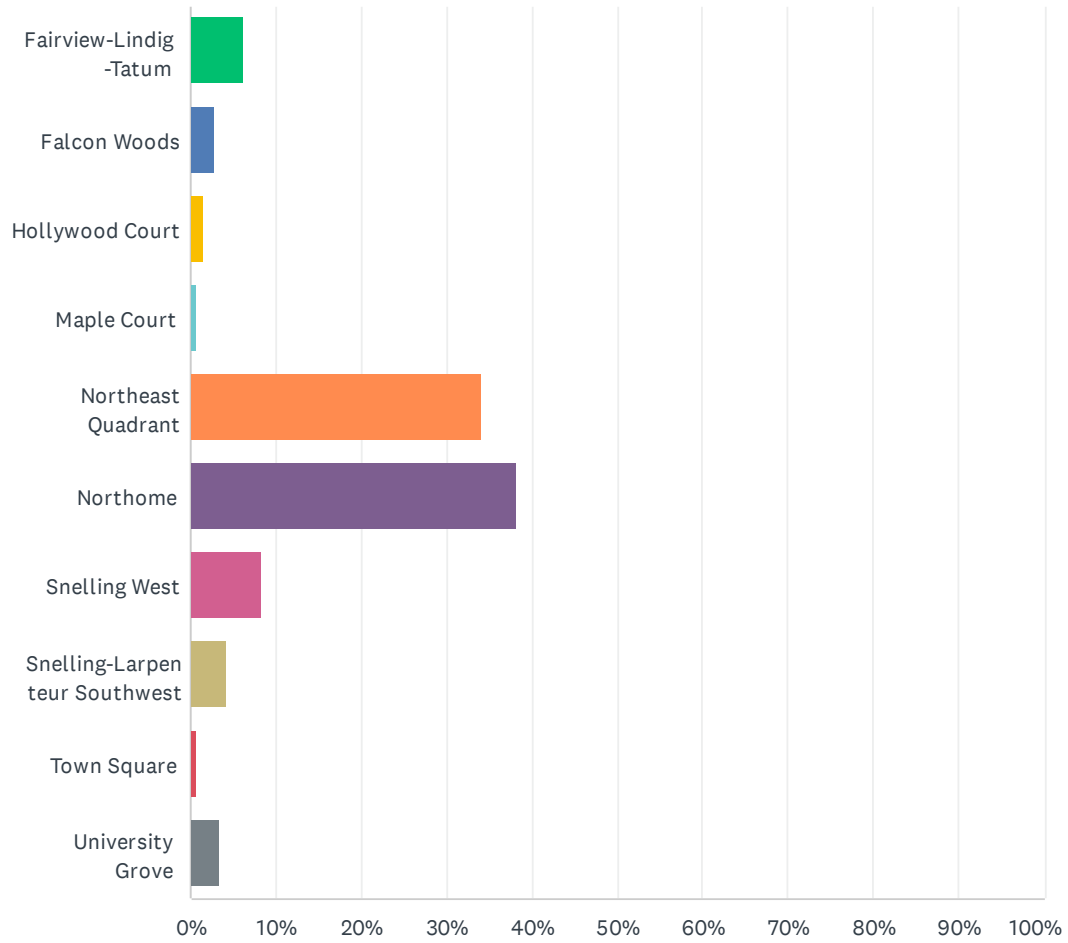

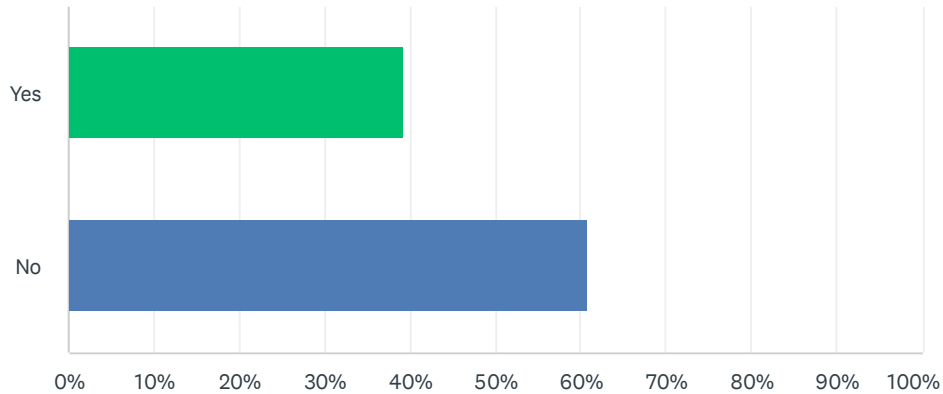

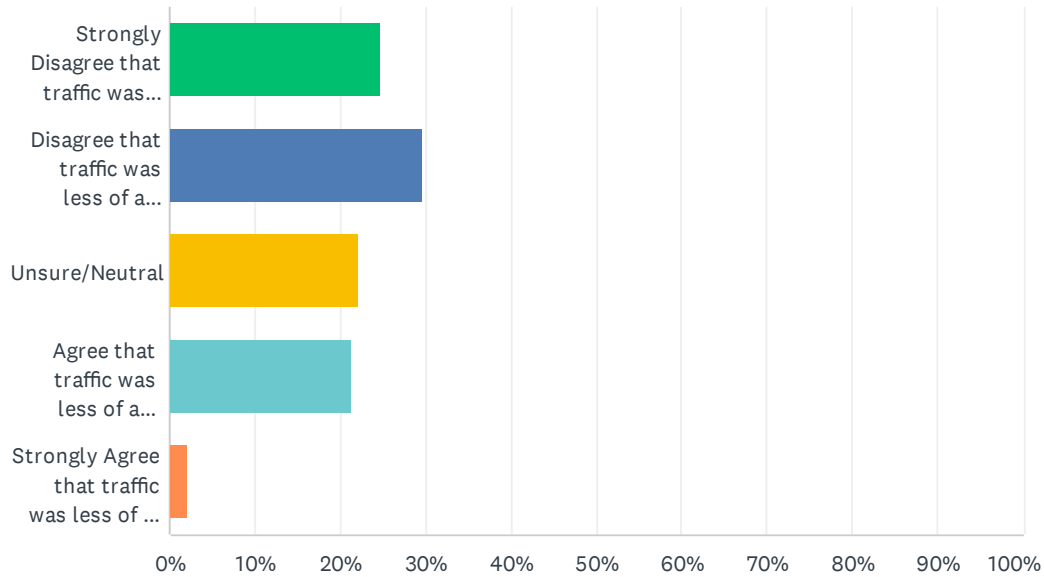

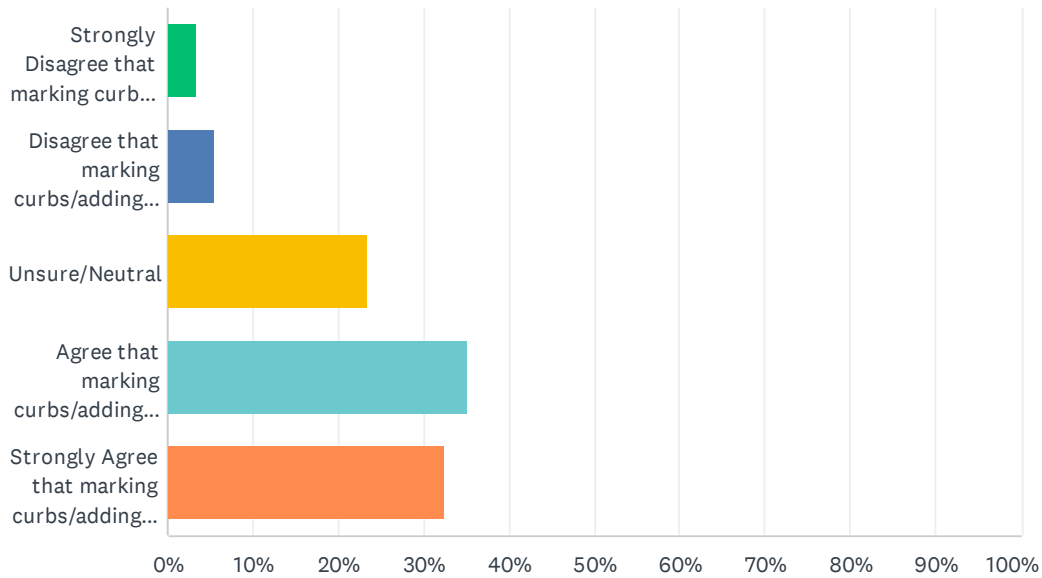

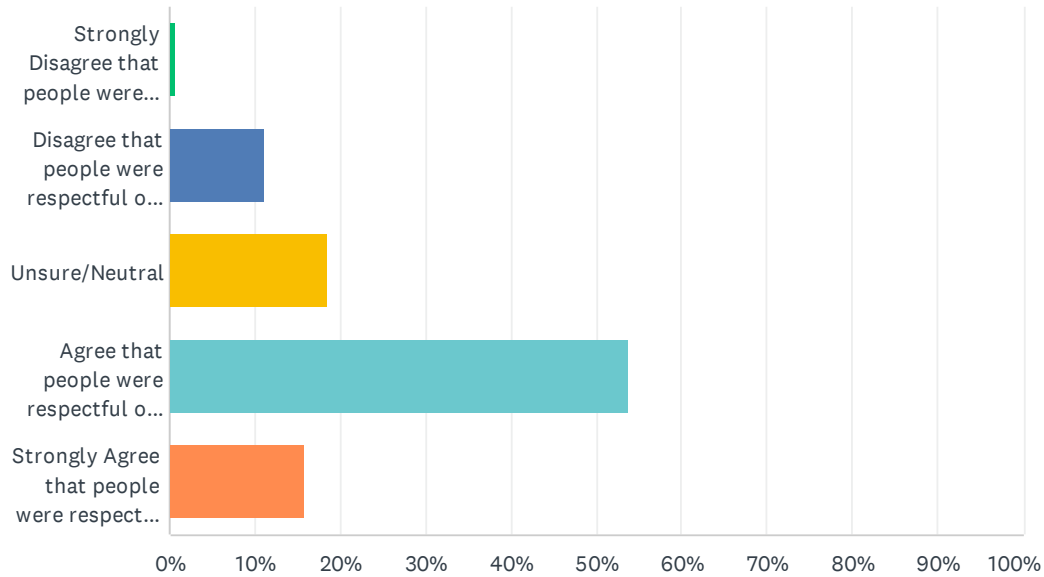

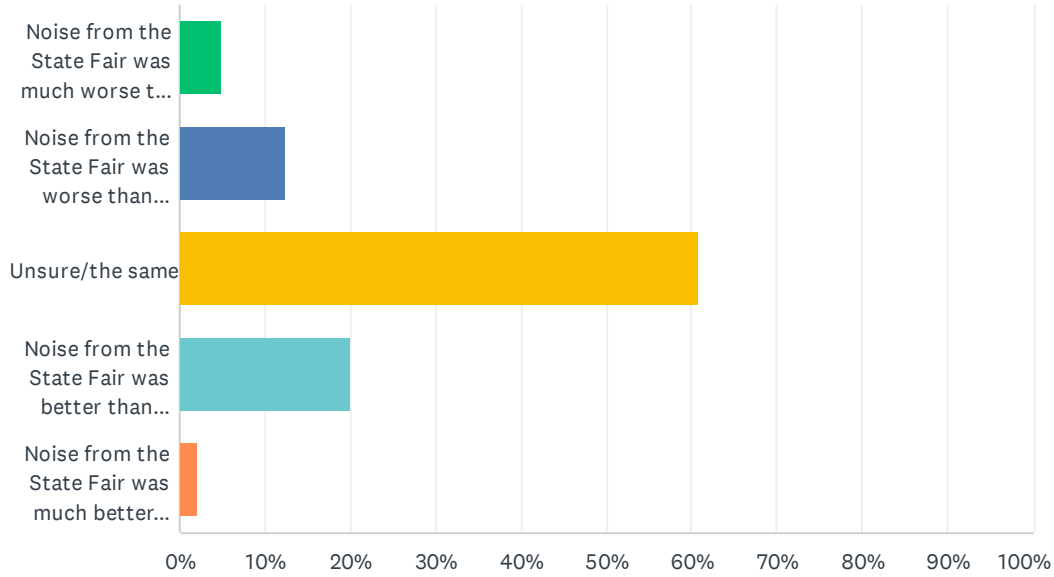

Q13 On a scale of Much Worse to Much Better, how would you rate the noise from the 2024 State Fair, whether fireworks, vehicles, music, people, etc.?

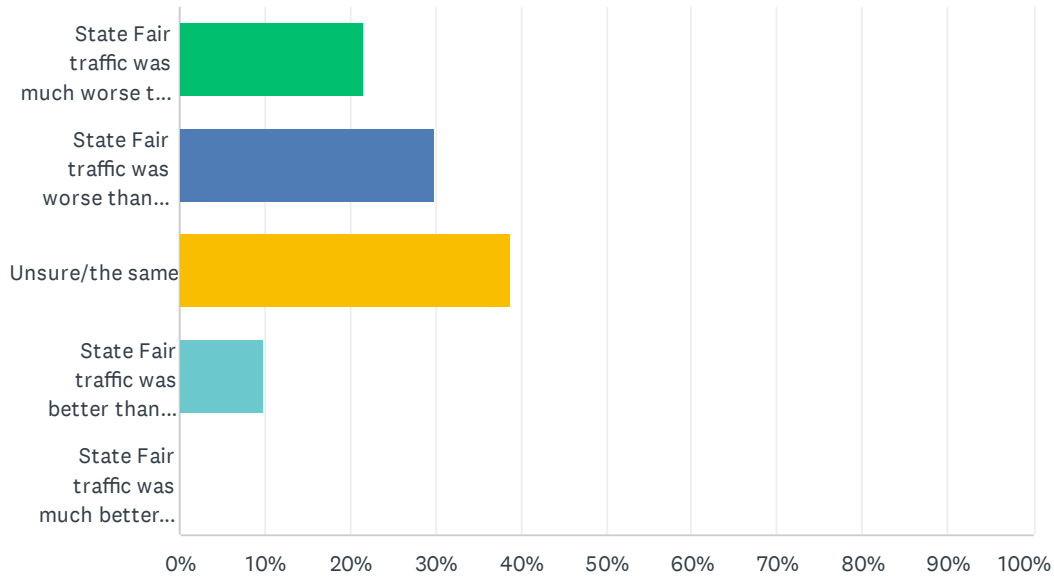

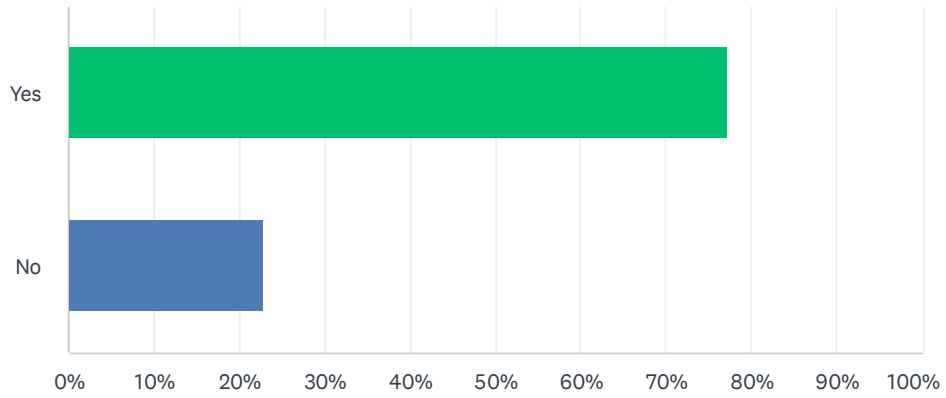

Item	Special Event Commercial Parking Lot Licensing
Description	<p>In the 2023 State Fair Task Force Report, it was noted that the regulation of commercial parking lots should be a future goal. As a reminder, the city does not allow parking in residential districts but does allow paid State Fair parking in commercial lots. The city does not regulate further beyond that, other than working with operators when complaints arise to ensure they are operating safely.</p> <p>A concern over temporary commercial lots is that some that operate lots should not be doing so, some businesses no longer have sufficient parking to operate, and parking lot operations often spill into roadways, causing safety concerns. A temporary licensing system would also give staff a point of contact in the event of an issue, as often the operator of a commercial lot is not the same individual as the owner.</p> <p>The proposed fee for a license is to be determined, but will ideally be just enough to cover staff costs without being burdensome to the business.</p> <p>Staff is seeking direction as to whether this is an area we want to explore further.</p>

ORDINANCE NO. 24-XX

**CITY OF FALCON HEIGHTS
RAMSEY COUNTY, MINNESOTA**

**AN ORDINANCE AMENDING TITLE 14 OF THE FALCON HEIGHTS CITY CODE
TO LICENSE SPECIAL EVENT COMMERCIAL PARKING LOTS DURING THE
MINNESOTA STATE FAIR**

THE CITY COUNCIL OF THE CITY OF FALCON HEIGHTS ORDAINS:

Section 1. Title 14 of the Falcon Heights City Code is hereby amended to add a new Article X to read as follows:

ARTICLE X. SPECIAL EVENT COMMERCIAL PARKING LOTS

Sec. 14-311. Definitions. Except where otherwise expressly stated, the following terms, wherever used in this chapter, shall have the meanings respectively ascribed to them in this section:

- **Special event commercial parking lot:** Any commercially zoned premises where motor vehicles are parked, stored, or allowed to remain for a fee during the Minnesota State Fair, specifically between August 15th and September 15th of each year.
- **Licensee:** The person or entity to whom a license is issued to operate a special event commercial parking lot.

Sec. 14-312. License required.

(a) No person shall engage in the business of operating a special event commercial parking lot during the Minnesota State Fair without a license required under this article.

(b) Each license issued under this article shall be subject to the provisions of this chapter and shall be valid only for the period specified in the license.

Sec. 14-313. License fees. The license fee for operating a special event commercial parking lot shall be as established in the City Fee Schedule. The fee shall be paid at the time of application.

Sec. 14-314. Licensing requirements.

(a) Application. Any person desiring a license to operate a special event commercial parking lot shall submit an application on forms provided by the city. The application shall include:

1. The name, address, and telephone number of the applicant.
2. The location and size of the proposed parking lot.
3. The maximum number of vehicles to be parked on the lot.

4. A general description of the security measures to be provided.
5. Any other information deemed necessary by the city.

(b) Review and approval. The city shall review the application, inspect the proposed site, and approve or deny the license based on compliance with city standards and regulations.

(c) Issuance. Upon approval, the city shall issue the license, which shall be prominently displayed at the entrance to the parking lot.

Sec. 14-315. License expiration. Licenses issued under this article shall expire on September 15th of each year.

Sec. 14-316. Operational requirements.

(a) The charge for parking shall be clearly posted at the entrance to the parking lot in letters of sufficient size to be readily seen from the street.

(b) The parking lot shall be maintained in a clean and orderly manner, free from litter and debris.

(c) Adequate lighting shall be provided to ensure the safety and security of patrons.

(d) The parking lot shall comply with all applicable federal, state, and local traffic laws.

(e) The licensee shall ensure that no vehicles are parked in a manner that obstructs sidewalks, driveways, or other access points.

Sec. 14-317. Insurance requirements.

No license shall be issued or renewed without proof of general liability insurance in an amount not less than one hundred thousand dollars (\$100,000) for injury or death to one person, three hundred thousand dollars (\$300,000) for each occurrence, and one hundred thousand dollars (\$100,000) for property damage. The certificate of insurance must be issued by an insurance company authorized to do business in the State of Minnesota.

Sec. 14-318. Enforcement and penalties.

(a) The city shall have the authority to inspect any licensed special event commercial parking lot to ensure compliance with this article.

(b) Any violation of the provisions of this article may result in the revocation or suspension of the license and/or a fine as established below:

- Operating a commercial parking lot between the dates of August 15 to September 15th without a valid special event license:
 - \$200 per parked vehicle per day

Sec. 14-319. Severability. If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this ordinance.
